15. Planning for conduction of Examinations will be prepared by Examination Department.

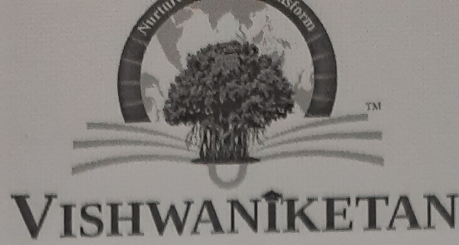


Dr. S. S. Inamdar mentioned regarding more representation from industry and parents is essential in IQAC.

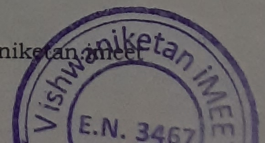

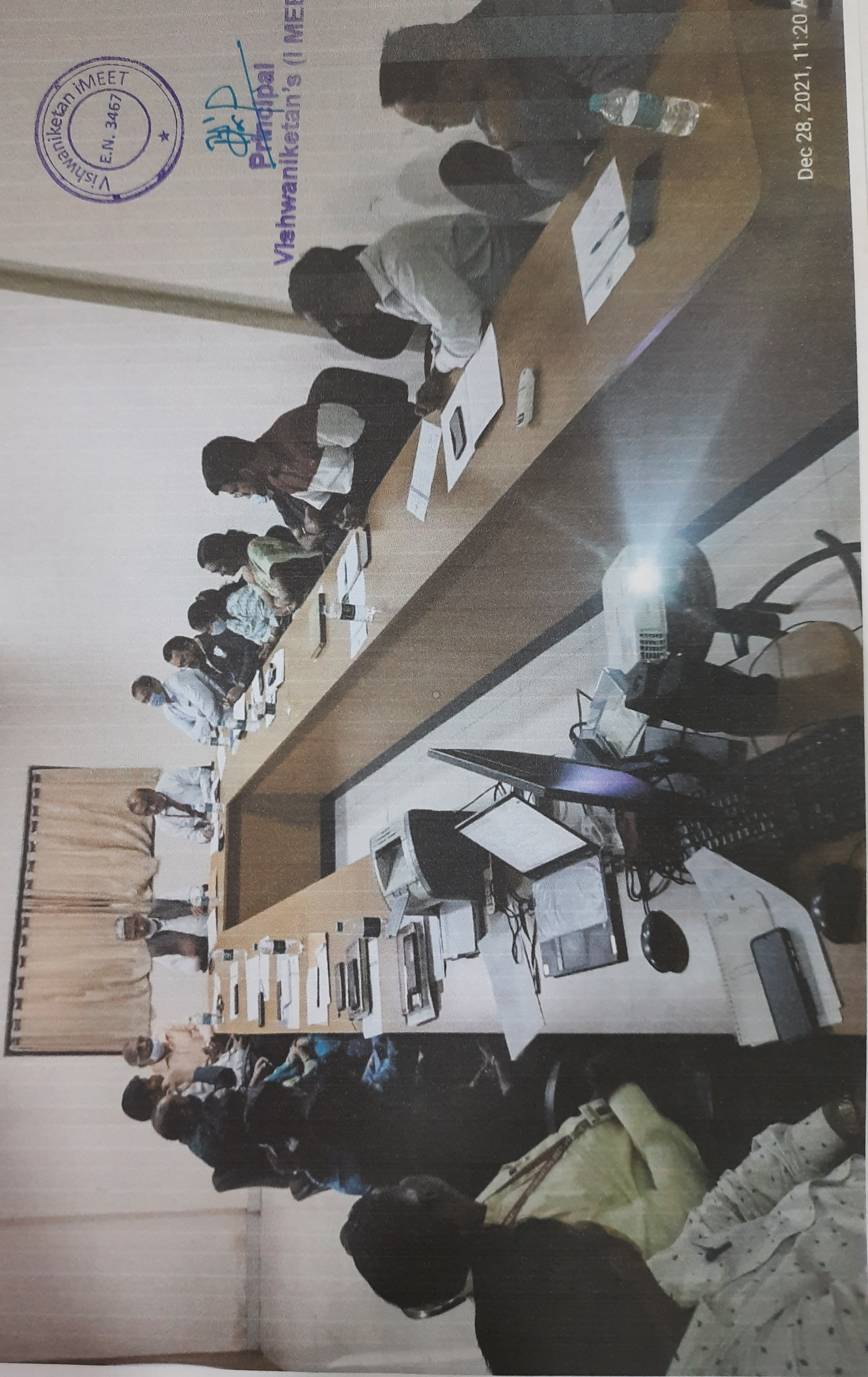


