The trainer must review the project (by physical presence at Vishwaniketan's iMEET, Khalapur Campus) at least twice in the semester. (The dates will be finalized mutually agreed on)

Project Exhibition for evaluation of projects will be conducted after completion of the course delivery & project. Certificates will be provided by training agency & ViMEET to all participants. The evaluation scheme will be as follows: 20% Marks course learning 30% Marks Assignment and Attendance 50% Marks—Project
